- 4. Competition Committee reserves the right to combine or split classes.
- 5. The decision of the judges is final.
- Protests must be made in writing, signed and submitted to the competition secretary by the end of the competition day and must be accompanied by a \$30.00 fee, refundable if sustained.
- All category changes must be emailed to: <u>psf.competitions@gmail.com</u> before June 29, 2018.
- All competitors must present current SOBHD registration card before receiving their number. Awards will be held and a \$5.00 fee charged for any dancer without a current SOBHD card.
- Prizes: \*\*Cash Prizes awarded in the 16 &

   classes. A special prize will be awarded for
   the Special Fling.
