1. All dancing events governed by the rules and regulations of the Scottish Official Board of Highland Dance.
2. Ages as of competition date.
3. Competitors will dance in reverse order of registration (first to enter is last to dance).
4. Competition Committee reserves the right to combine or split classes.
5. Protests must be made in writing, signed and submitted to the competition secretary by the end of the competition day and must be accompanied by a \$30.00 fee, refundable if sustained.
6. All category changes must be emailed to: [ihda.secretary@gmail.com](mailto:ihda.secretary@gmail.com) before February 12, 2019.
7. All competitors must present current SOBHD registration card before receiving their number. Awards will be held and a \$5.00 fee applied for any dancer without a current SOBHD card.
8. Prizes: \*\*Cash Prizes awarded in the 16 & Over Premier Classes and medals in all other classes. A special award will be given for the Special Fling in Beginner and Novice, as well as for the Hornpipe Challenge in Intermediate and Premier.
9. Absolutely no late entries will be accepted.
10. There will be NO entry fee refunds.
11. Absolutely NO telephone, email, mail or hand delivered entries.
12. Dancers filling in for the Reel must dance the entire dance
13. \* Special Fling does not count towards the aggregate. It is a standard 4 step Fling that is awarded a special prize.
14. \*\* Hornpipe Challenge does not count towards the aggregate. It is a 4 step Sailor's Hornpipe with steps to be chosen by the Judges on the day of competition.
15. Dancers must comply with the SOBHD Code of Conduct. Failure to do so will result in the dancer being reported to the SOBHD.
