Championship and Closed Competition Information

- 1. SOBHD rules govern the competition. Dancers will compete in their own age groups only. Proof of age must be shown if requested.
- 2. SOBHD Registration Number must be shown to receive a competitor number. If SOBHD card not shown, \$5 fee will be charged and medals withheld until card is shown.
- 3. Entries:
 - No phone, fax, mail or e-mail entries accepted. No refunds will be given.
 - Field Entries will not be accepted.
- 4. Entry Fee: Dancers must show a membership card from a local Highland Dancing association to be eligible for the subsidized fee.
- 5. Awards:
 - Dancers must remain in full costume, including dance shoes, for presentation of awards.
 - Aggregate Awards: The SOBHD scoring system will be in effect: 137, 91, 71, 53, 37, 23
- 6. Status Changes must be emailed to Kerilyn Voigt at battlefordshighland@gmail.com no later than May 22/19.
- 7. The decision of a judge is final. Protests must be in writing and handed to the Competition Chairperson on the day of the competition, accompanied by a \$15 fee which will be refunded if sustained.
- 8. Cameras: Flash cameras are not allowed during the competition. Video recordings may be made from designated areas only.

Championship:

- The Saskatchewan Closed Provincial Selection Championship is sanctioned and governed by the rules & regulations of the Scottish Official Board of Highland Dancing and ScotDance Canada. All dancers must show a current SOBHD Dancer Registration card to register.
- 2. Age is to be taken as at July 1 for determining the age classification in which dancers would enter the Canadian Championship. Thus, in preliminary championships or competitions used to select provincial representatives, dancers would compete according to their age on July 1 of that year.
- 3. ELIGIBILITY: For eligibility to compete in the Canadian Championship, a dancer must qualify in a Closed Provincial Championship or Selection Competition determined by birth or having been a resident for six (6) months immediately prior to the Closed Provincial Championship or Selection Competition. In the event a dancer qualifies to compete in two (2) Closed Provincial Championships and/or Selection Competitions, one by birth and one by residence, the dancer may only compete in one (1) for that calendar year. Dancers born outside of Canada may only qualify by residency to compete in a Closed Provincial Championship or Selection competition. For dancers under the age of 18 years, the residence of their legal guardian will determine residency.
- 4. All dancers must dance the 2019 SOBHD Championship steps. The 7 Years & Under 10 Years class and the 10 Years & Under 12 Years class will dance cut steps as set out by the SOBHD. Championship steps must be danced regardless of whether or not there are sufficient numbers in the section to qualify as a championship. If a championship class is cancelled due to insufficient entries, all dancers age 12 and over must dance the 2019 SOBHD Championship steps no cut steps.
- 5. Awards: Will be given up to 6th place. Dancers must remain in full costume, including dance shoes, for presentation of awards.
- 6. Judges Sheets: Will be available for purchase at a cost of \$2 a set.
- 7. AGE GROUPS: 7 to Under 10 years, 10 to Under 12 years, 12 to Under 14 years, 14 to Under 16 years, 16 to Under 18 years, 18 to Under 21 years, 21 years and over
- 8. Order of Dance: There will be a draw for order for the Saskatchewan Provincial Championship for the Fling, Sword and Seann Truibhas. This Draw will be held prior to May 25th. There will NOT BE A DRAW FOR THE REEL first to enter, last to dance.

Closed Competition:

- 1. Age: Age for Closed Competition is as of May 26th, 2019.
- 2. Classes: to be divided at discretion of competition chair, depending on the entries received at closing.
- 3. Awards:
 - Medals will be to half the number of dancers dancing plus one, to a maximum of six placings.
 - Aggregate trophies will be presented except for Primary.
- 4. Eligibility: As this is a closed competition, dancers must be a Saskatchewan resident or a member of Cross Border Highland Dance for six months immediately prior to this event.
- 5. Order of dance: Dancers must be on hand to dance in numerical sequence, or forfeit the right to dance in that event. Last to enter, first to dance.
