- Protests must be made in writing, signed and submitted to the competition secretary by the end of the competition day and must be accompanied by a \$30.00 fee, refundable if sustained.
- All category changes must be emailed to: <u>ihda.okcompetitions@gmail.com</u> before February 1. 2020.
- All competitors must present current SOBHD registration card before receiving their number. Awards will be held and a \$10.00 fee applied for any dancer without a current SOBHD card.
- 8. Prizes: \*\*Cash Prizes awarded in the 16 & Over Premier Classes and medals in all other classes. A special award will be given for the Laddie Challenge in Intermediate and Premier.
- 9. Absolutely no late entries will be accepted.
