Also, because of this, category changes will happen between the days should a dancer fill their dance card on the Saturday.

All Platform Schedules, Class Lists and Results will be posted on the ScotDance App. The ScotDance App can be downloaded at the Apple App Store, Google Play Store or by visiting scotdance.app from your internet browser.

RULES AND REGULATIONS:

- 1. All dancing events are governed by the rules and regulations of the Royal Scottish Official Board of Highland Dancing (RSOBHD) and ScotDance Canada.
- 2. This event may be cancelled at any time up to, and including on or during the date of competition, depending upon public health concerns.
- 3. Ages as of competition date. February 22, 2025 for S.O.S and Febr0uary 23, 2025 for IHDA.
- 4. Competitors will dance in reverse order of registration (first to enter is last to dance).
- 5. Online entries will be accepted from 8:00am PST December 20, 2024, through 11:59pm PST February 07, 2025.
- 6. No late entries will be accepted.
- 7. There will be NO entry fee refunds. If admittance to the event is refused based upon good health declaration, fees will be refunded except for an administration fee of \$5.00 per family.
- 8. Absolutely NO mail, telephone, email, or hand delivered entries.
- 9. The Competition Committee reserves the right to combine or split classes.
- 10. The decision of the judge(s) is final.
- 11. Protests must be made in writing, signed and submitted to the competition secretary by the end of the competition day and must be accompanied by a \$35.00 fee, refundable if sustained.

- 12. All category changes must be emailed by February 17, 2025 to: secretarysos11@gmail.com for February 22 events and to: ihda.okcompetitions@gmail.com for February 23 events.
- 13. All competitors must be registered with the RSOBHD or RSOBHD subsidiary body (such as ScotDance Canada) to compete. All competitors must present a current RSOBHD registration card before receiving their number. Awards will be held, and a \$10.00 fee applies for any dancer without a current RSOBHD card.
- 14. Change Room facilities will be available and changing in washroom facilities will not be permitted.
- 15. Dancers must be always dressed appropriately.
- 16. Dancers filling in for the Strathspey & Highland Reel must dance the entire dance.
- 17. All competitors must remain in costume for award presentations.
- 18. Prizes: **Cash Prizes awarded in the 16 & Over Premier Classes and medals in all other classes. A Special award will be given for the Special Fling in Beginner and Novice.
- 19. *Special Fling does not count towards the aggregate. It is a standard 4 step Highland Fling that is awarded a special prize.
- 20. Dancers and parents must respect the ScotDance Canada Risk Management Guidelines, Local Health Authority directives, and the RSOBHD Code of Ethics.

However, the Interior Highland Dance Association of BC (IHDA) and S.O.S Kildonnan Camp Society (SOS) cannot guarantee that you (or your child, if participant is a minor/ or the person you are the legal guardian of) will not become infected with COVID-19/other contagions. I declare that neither I (or my child, if participant is a minor/or the person I am the legal guardian of) have tested positive for COVID-19/other contagions, and have not yet been cleared to discontinue isolation in accordance with applicable criteria communicated by public health officials (awaiting results); have been in close contact with a person who, to my knowledge, had symptoms of COVID-19/other contagions or has tested positive for COVID-19/other contagions, and have not yet been cleared to discontinue isolation in accordance with applicable criteria communicated by public for COVID-19/other contagions, and have not yet been cleared to discontinue isolation in accordance with applicable criteria communicated by public health officials; or am currently subject to a quarantine or self-isolation order for any reason, including travel.
